## SPECIAL SERVICE CLUB

THE SONOMA COUNTY RADIO AMATEURS, INC. IS NOW IN THE PROCESS OF IMPLEMENTING THE SPECIAL SERVICE CLUB. IT MAY NOT CHANGE TOO MANY OF THE PROGRAMS THE CLUB HAS BUT IT MAY BRING THEM INTO SHARPER FOCUS.

WHAT IS THE SPECIAL SERVICE CLUB PROGRAM? IT IS A NEW PROGRAM TO DEAL WITH LOCAL PROBLEMS OF AMATEUR RADIO AT THE LOCAL LEVEL IF AT ALL POSSIBLE. THIS DOES NOT MEAN THAT WE ARE COMPLETELY ALONE, NO WAY, ARRL IS STRUCTURED TO HELP VIA THE CLUBS ARRL LIAISON MEMBER. THIS IS A CLUB PERSON WHO CAN GET TO BE SO WELL ACQUAINTED WITH THE WORKING OF ARRL THAT HE WILL KNOW WHERE AND TO WHOM TO ASK FOR HELP OR HAVE A QUESTION ANSWERED. ALSO THERE IS THE ACC (AFFILIATED CLUB COORDINATOR) WHICH IN OUR AREA IS THE SCM, WHO WORKS WITH THE ARRL TO SEE THAT THE CLUB IS MOVING IN THE RIGHT DIRECTION.

A SPECIAL SERVICE CLUB CAN WORK IN ONE OR SEVERAL DIRECTINS, DEPENDING ON MEMBERSHIP NUMBER AND INTEREST. THE FOLLOWING ARE SOME OF THESE:

A. PUBLIC RELATIONS-IMPROVE VISIBILITY AND PROMOTE A POSITIVE IMAGE LOCALLY.

B. EMERGENCY COMMUNICATIONS-COOPERATE WITH RACES/ARES, AND OTHER ORGANIZATIONS IN THIS AREA, CDF, RED CROSS, ETC..

TRAINING-NOVICE CLASSES AND UPGRADE CLASSES, CONTINUED TECHNICAL EDUCATION TO KEEP THE CLUB UP WITH THE OUTSIDE WORLD.

TECHNICAKL ADVANCEMENT- VIA LIBRARIES, GROUPS, ON TECHNICAL SUBJECTS.

E,F- INTERFERENCE PROBLEMS, RFI AND JAMMING, FIELD DAY, OPERATING UPDATING, TRAFFIC NETS, LIAISON WITH LOCALGOVERNMENT, CLUB MAILING ADDRESS, NEWSLETTER, SLIDE AND VIDEO TAPE SHOWS, BOY SCOUTS, AMATEUR RADIO IN LOCAL SCHOOLS, AND MANY MORE PROGRAMS.



W5YI REPORT SEPT 15, 84.

ROBERT S. FOOSANER, CHIEF FCC PRIVATE RADIO BUREAU, SAID "THE SPECTRUM REQUIREMENTS FOR THE 220 - 225 MHZ BAND ARE: CURRENTLY UNDEFINED. THE SECOND REPORT AND ORDER IN GENERAL DOCKET 80-739, RELEASED DE. 8, 83, REGARDING THE IMPLEMENTATION OF THE FINAL ACTS OF THE WORLD ADMINSTRATIN RADIO CO FERENCE, GENEVA, 1979, STATED THAT BOTH THE FCC AND THE NATIONAL TELECOMMUNICATIONS AND INFORMATION DMINSTRATION ARE STUDYING POSSIBLE USES OF THE 216-225 MHZ SPECTRUM. THUS, IT IS NOT APPROPRIATE TO CONSIDER PETITIONS WHICH COULD HAVE A MAJOR IMPACT ON THE 220 MHZ BAND UNTIL THESE MATTERS HAVE BEEN RESOLVED."

MEANWHILE THE TWO RECENT PETITIONS FILED BY THE LAND MOBILE COMMUNICATIONS COUNCIL(8RM-4829) AND SIDE BAND TECHNOLOGY, INC. (RM-4831) CONTINUE TO DISTURB THE AMATEUR COMMUNITY.

NEW FCC FORM 610 TO BE RELEASED

LARRY WEIKEERT, FCC GETTYSBURG, PA. ADVISES THAT THE NEW VERSION OF FCC FORM 610. APPLICATION FOR AMATEUR RADIO STATION AND/OR OPERATOR LICENSE WILL BE AVAILABLE ON SEPT. 17TH. THIS VERSION WILL HAVE THE NEW VOLUNTEER EXAMINER TEAM REPORT ON THE REVERSE SIDE.

THERE WILL ALSO BE SOME OTHER DIFFERENCES TO CONFORM TO THE NEW VOLUNTEER TESTING PROGRAM. ALL FCC FIELD OFFICES AND VEC'S WILL HVE THE NEW FORM AVAILABLE. THERE HAS BEEN A DELAY IN GETTING THIS FORM RELEASED DUE TO THE VARIOUS AGENCY REVIEWS REQUIRED BY THE PAPERWORK REDUCTION ACT OF 1980.

HAM BAND SHARING WITH OTHER USERS

IN A NOTICE OF PROPOSED RULEMAKING RELEASED LAST MAY (FCC DOCKET 84-169), THE FCC PROPOSED TO ALLOW SPREAD SPECTRUM USAGE FOR LOW POWER (PART 15) COMMUNICATIONS ON FREQUENCIES ABOVE 70 MHZ -- INCLUDING THE AMATEUR BANDS.

FEDERAL PREEMPTION --ANTENNA ZONING

ON JULY 16, 84 THE ARRL FILED A REQUEST FOR ISSUANCE OF DECLARATORY RULING REQUESTING THE COMMISSION TO EXERCISE FEDERAL PREEMPTIVE AUTHORITY OVER STATE AND LOCAL ZONING REGULATIONS WHICH AFFECT TRANSMITTER AND ANTENNAS USED BY AMATEUR RADIO OPERATORS.
