Don't Touch That Dial!

At the SCRA Flea Market on Saturday, September 18, there was some concern that Radio Clinic's FM deviation measurements were reading too high. In fact, when later verified against a calibrated signal generator, the readings were about 2% low. The error was not in the test equipment, but in the advice of what the measurement should be. The Radio Clinic measures peak-to-peak FM deviation. For a transmitter with 5 kHz peak deviation, it should ideally measure 10 kHz peak-to-peak. Most of the HTs tested were very close to 10 kHz peak-to-peak.

Unfortunately, the advice given was that the ideal measurement would be about 7.5 kHz. This assumes measuring peak-deviation (NOT peak-to-peak) and adding the modulation bandwidth (typically 2.5 kHz). This is really a measure of the FM bandwidth, not FM deviation.

In summary, if your radio measured approximately 10 kHz peak-to-peak deviation there is no need to readjust it. Sorry for any confusion this may have caused.

SCRA TRANSMITTER HUNT

Thanks to all those who chanced what weather there might be to participate in the 2 meter transmitter hunt on Saturday, Oct. 16. Sixteen of you signed up for the hunt, twelve calls were logged at the starting location, and about eighteen showed up at the fox location. Teams logged in at the beginning were:

There were more hams involved as part of the above teams, whose calls do not appear above; sri.

The foxes were hiding at Lake Ralphine in Howarth Park, right on the edge of the seven-mile radius limit. This year, the winner was the KC6BSI team, with a mileage number of 10.2 miles. Runner up was the KC6RHA/KC6NDU team with 16.1 miles. The KC6BSI team used a four-element yagi and an attenuator mounted on a short hand-rotatable mast to locate the foxes.

When time was getting short because of threatening weather, the foxes decided to give their location so that all could meet and enjoy the surprise festivities. The fox team had hamburgers and hot dogs cooking on the grill as the teams arrived. These goodies along with homemade potato salad, chips, and drinks made a very tasty lunch for all participants.



Several teams had other commitments for that day and could not join the rest of us at the fox site after a morning of hunting. We are all sorry you were unable to attend, but we each had a hamburger in your honor. To these folks and ALL who participated, we thank you for making this fox hunt a success and an enjoyable event for all who stalked the fox.

The foxes of 1993 challenge the new foxes of 1994 and all future foxes to make this event even more fun and enjoyable in the coming years. As a suggestion, several smaller hunts could be organized throughout the year with smaller areas of search; say two miles from the starting point. This would give more people a chance to participate, and make the foxes think of trickier ways to not be found. Skills would be better developed with more than one hunt per year.

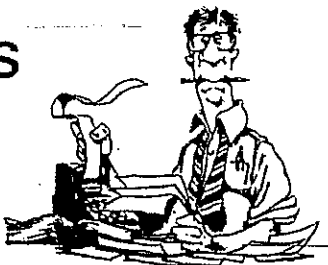

VISITORS: Shelly KD6AFZ introduced six visitors.

ARES/RACES/VIP Meeting

Saturday, September 25th, four of us traveled to Willits to attend a regional ARES/RACES/VIP meeting conducted by John W6TLK, ARRL San Francisco Section Manager, and Dale WB6TMS, SF Section Emergency Coordinator. The following subjects were covered:

1. **VIP** (a Calif Dept of Forestry abbreviation for Volunteers in Prevention). A standard nickname is now commonly used for a licensed amateur VIP assigned to an official: a "shadow". Dale covered a number of details about the requirements of a shadow. Bob AA6VS, Larry K6CQE, and Frank W6MN took notes and would be happy to go over these details upon request. It is obvious that we need more training to bring us all up to date.

Several years ago, a number of ABARC members attended the first training session offered in our area, at the CDF in Pt. Arena. Bob Sears is checking on the possibility of us having added sessions to come up to speed in the VIP "shadow" area.

2. **ICS**: Closely related to our potential work as VIP "shadows" is the need to be prepared for ANY kind of incident involving local and/or visiting jurisdictions. The initials ICS stand for Incident Command System. This system is being universally adopted, at least in our state and, if I recall, even nationally.

It behooves us to be trained in this system. Whenever a disaster mushrooms into a multi-agency incident, ICS provides a standard way to organize and communicate. The first agency leader on the scene usually becomes the Incident Commander — even when higher authorities are present. Communications between agencies is a need which we can fill.

An excellent example was cited: the recent "Tire Fire" at Santa Rosa. What started as a call-out of the nearest fire company turned into a complex situation involving some 20 or

more agencies plus lots of press. Such incidents will likely require our help to provide communications between many agencies who may not always have common frequencies.

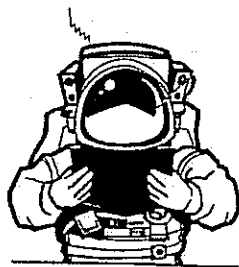
3. **Toxic Materials and Waste**: At the Willits meeting, we received two handouts covering toxic materials and waste. The one entitled, "You Have a Right to Know", is directed mainly at those working in industry or the like. The second is a fine, small booklet entitled, "1990 Emergency Response Guidebook", a guidebook for first response to hazardous materials incidents.

4. **Area Reports**: John called upon district and local emergency coordinators to report on their ARES, VIP and RACES activities. The details are too numerous to include here, but any of the attendees from our club would be happy to talk over these details with anyone who is interested.

Pretty good DX!

The Russian MIR space station continues to orbit the earth after some seven years, and the latest crew is using the call R0MIR for FM voice and R0MIR-1 on packet. It makes several passes a day over Sonoma County, and can easily be heard...even on a HT with a rubber ducky! Just set 145.55 into your radio and wait. Even if you don't have a computer tracking program, set that frequency into your packet program and watch for activity.

Digital contacts with the on-board Personal Message System are easy with whatever setup you now use for terrestrial work. Orbits are about 1 hour 35 minutes apart, and "good" passes generally happen in three's and fours, followed by 12 to 15 hours of silence. Unless there is a US Space Shuttle SAREX mission aloft, activity on this frequency is almost certainly the Russian spacecraft. And if you are lucky, you'll hear either Vasily or Aleksandr on regular NBFM. This crew is more chatty than previous ones, so give it a try.

BIG CHANGES MAY BE JUST A YEAR OR TWO AWAY for the Volunteer Examiner Amateur License Testing Program. In a proposed notice of rulemaking, the FCC wants to allow VE's to file test results electronically and to issue temporary call letters on the spot! Soon, that interminable eight to twelve week wait that all new hams endure may be a thing of the past. Here's how it will work:

When an applicant qualifies for a new Novice or Technician license, the Volunteer Examiners would immediately issue a CSCE and a temporary call. They would then file an electronic Form 610 by modem to the FCC license facility in Gettysburg, PA. There, a regular permanent call would be assigned and the license printed and mailed out, all within a few days.

The temporary call would be a 2x6: the prefix 'WC,' the call district number, the individual's initials, a slash bar, and a two letter class-of-license designator. In other words, if Mary Jane Harris of Sebastopol went to the SCRA Swap Meet this September and passed elements 2 and 3A to qualify for a No-Code Tech license, she would be issued the call WC6MJH/KT on the CSCE. She could then leave the VE session, and from the parking lot pick up her new 2 meter HT and call her ham husband (monitoring 6.73 while driving through Novato) with the good news!

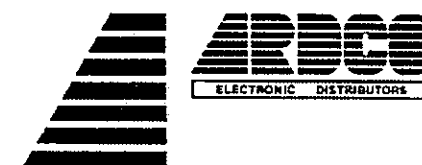
Earlier, the FCC brought Novice testing into the VE program, and will allow General class hams to become Volunteer Examiners for license exams up through Tech Plus. This is in addition to the present Advanced VE's, who can test up through General, and Extra VE's who test for all grades of license. These new moves, especially the instant operating authority for new hams, will most likely spur another wave of interest for our hobby! *Tnx ARRL.*

LATEST CALLS ISSUED are AB6VY for Extra, KN6QI for Advanced, and KE6AOT for all other classes. The FCC appears ready to begin issuing club and military calls once again, most likely through one or more VEC's. These will be of a unique series NA-NZ and in the 2X3 format. The ARRL has filed a request

with the Commission to become the exclusive licensing entity, claiming that any other plan will only lead to confusion.

CHOOSE-YOUR-OWN CALLSIGNS? the FCC's Ralph Haller claims that when the FCC's new computer system is operational, hams will be able to file requests for special call signs. Except for a brief period when Extra Class hams were allowed to pick any unused call, the FCC has consistently denied all requests for exceptions to the machine-generated sequential issuance of calls. A special fee will definitely be part of the plan, probably \$75 or more. The process of applying will be somewhat similar to the procedure for special vehicle plates: listing your choices in order of preference. It's expected this will generate a flurry of activity, as many will want to recapture former calls lost by forgetting to renew a license or those once held by loved ones. As it looks now, any unused combination that conforms to the format authorized by your license class will be issued on a first-come first-served basis. Don't rush for the callbook just yet. This is at least two years away. *Tnx Newsline and ARRL.*

LICENSE FEES FOR HAMS were averted by the ARRL's actions during negotiations over the recently-passed Budget Reconciliation Act. One draft version of the bill included an annual regulatory fee on every licensed radio amateur. The fact that we continue to provide important services in times of disaster and emergencies played heavily in our being spared this additional tax, which almost certainly would have had a negative effect on attracting new converts to our hobby. It's a good point to remember the next time the call goes out for help in a public service event or training exercise. Thank you, ARRL, for pointing out the value of our efforts to our "friends" in Congress. Check page 9 of the September issue of QST for an update of the new rules governing such activities. *Tnx Hamnet.*
