





### Vanity "Preferred" Call Signs -No Start Date but Significant News:-

It appears as though the program for the actual application for call signs, other than the sequentially issued club call sign part of the program, will continue to be delayed, perhaps until 1996.

The NEW news is that the FCC has issued a Memorandum Opinion and Order to PR Docket 93-305 disposing of the Petitions for Reconsideration on vanity calls.

The effective date of these rule changes is Nov. 17, 1995. NOTE: THIS IS NOT THE "START DATE" FOR THE PROGRAM. The 610-V still is NOT available, and the date for the opening of Gate One has NOT been announced.

In brief, the following changes were adopted:

- 1. Call signs reflecting locations outside the contiguous 48 states are reserved for stations "whose licensee's mailing address is in the corresponding state, commonwealth or island." In requesting call signs in the mainland 10 call areas, applicants are NOT limited by their location.
- 2. Exceptions to this limitation apply to close relatives of deceased amateurs, and former holders of a call sign. So, if a former KH6 amateur now living on the mainland wants his KH6 call back, he will not have to have a Hawaii mailing address to do it.
- 3. To obtain a call sign, the licensee MUST hold the requisite class of license. For example, if you held W3BE and let it lapse, you will have to get your Extra to get it back. The same concept applies to close relatives of deceased amateurs. There are some very subtle details concerning Group A, B, and C call signs and, in particular to Pacific island calls in these groups. Please see FCC Amateur Station Sequential Call Sign System, Fact Sheet PR-5000 #206, dated February 1995 and the ARRL FCC Rule Book to be sure you understand the details.
- 4. There will be another gate, One A, for clubs which held club call signs prior to March 24, 1995 who apply to obtain the call sign of a deceased member.
- 5. The FCC has not stated how they will handle APO/FPO addresses.

The fee for a vanity call sign has already been reduced by the FCC to \$30 for a ten year period.

### Pacific Division Ham Shot -Saved by Ham Radio:-

Rory Clark, KD6RKL, of Citrus Heights CA, a suburb of Sacramento, was shot while standing at a bank automatic teller machine. Using his hand-held transceiver, he called for help on the N6ICW repeater, owned and operated by Chris Huber. As a result, he was able to obtain medical assistance promptly. In the words of local authorities, "That contact saved Rory's life."

Local hams rushed to his and his family's assistance, and continue to be of support. Among them was Jim Rosima, KD6SSW, who took Clark's family to the hospital after the incident.

Rory is a member of the River City ARC and the North Hills RC in Sacramento.

As of mid October, Rory was home and recovering well. Good luck, Rory, and thanks to all were involved! Thanks to ARRL PIO, John Arndt, KD6SSZ, who was the source of this story.



## Board Meeting Minutes

October 11, 1995

The meeting was called to order at 5:40 PM by President Kelly Cureton KD6CJQ in the meeting room at the Northbay Savings Bank. Other officers present were Secretary Al Bloom N1AL, Treasurer Angela Dickey KC6OCD, Activities Chairman Joel Nadler KJ6LF, Repeater Chairman Jim Rutherford WB6PER, and Members-at-Large Marie Mappus KI6QY and Jim Andrews KC6PJW. Also present were 5 other SCRA members.

**AWARDS** are traditionally handed out at the Christmas Party. Possible recipients were discussed.

The **NOMINATING COMMITTEE** is hard at work dragooning potential officers for next year. One very important non-elected position is Public Service Coordinator. Marie KI6QY will check on some potential candidates.

Marie also noted that no smoking or drinking is allowed on state property. That includes the CDF communications van and the RACES trailer.

**DUES:** Jim WB6PER read a 6-page statement on why we need to raise the dues to \$25 (plus \$12.50 per family member) plus \$10 initiation fee. A long discussion ensued about upcoming expenses, required income, and how best to match the two figures.

A **NORTH POLE NET** will be again be run during the Christmas season by Jim KE6FSK. It will be based at the Two Rock Coast Guard base this year.


TREASURER Angela KC6OCD wrote a \$100 check for Newsline, as previously authorized. She collected receipts for repeater expenses from Jim WB6PER. The final \$1500 check to Mike Aber for the repeater purchase was written. With the good Flea Market results and the donations at the last couple meetings, we are only over budget about \$500, despite the unexpected \$3000 payment for the new repeaters.



## **NEW CLUB STATION**

The Old Timer sat in his living room with the young kid just entering amateur radio. They were looking on the walls at DXCC & a host of awards - and the kid was asking questions,..

"Back in the old days before the hams had access to the club station at two rock, did everyone have these awards?" "No son, before we got the two rock station, very few hams could get a wall of awards like this,.. why, you had to have your own station & usually a pretty good antenna to go with it."

"Of course that was long ago. It didn't catch on right away, but when the fellows discovered they could make a short drive out to Two Rock at the Coast Guard - well it didn't take long to generate wall paper all over Sonoma County."

"Why, they have FIVE operating stations out there in a small house! No TVI and what stations!

#1 Icom 781 one of the latest state of the art rigs, a lot of us saw it & got to use it on field day. It has a spectrum analyzer/panadapter on the front panel. Teamed up with it is an SB201 amplifier & a TH7 tribander beam on a 55 ft. tower. You have an effective radiated power on this station of at least 3024 watts!

#2 Another Icom 781 this time with another 55ft tower located across the property so it can be used at the same time as station #1. It has a TL922A amplifier & a Moseley PRO95 that covers 20-17-15-12-10 meters with an ERP of 4800 watts!

#3 TS440S running barefoot on a folded 40 meter dipole. It has a keyer with a bencher paddle.

#4 TS680S this rig includes 6 meters & has an 80 meter dipole cut for the phoneband


#5 FT736R controlled by a computer to work a variable azimuth-elevated antenna on satellites. This station also works two meter packet & other "goodies." ALSO: a whole lot of other rigs for VHF/UHF bands."

Well the Coast Guard couldn't be more helpful, the hours are 5PM to 10PM Monday through Friday & on Saturday 12Noon to 6PM." The station has a kitchen & bath, even a work bench to work on your rig & even has sleeping areas for running a special event or contest station overnight with special arrangements."

Sure enough son, you can just run out there & in no time at all you will have more "fire power" than almost any old timer ever thought of having on his own station at home. If you have a friend far away, a net to run, or just general hamming - its the place to go. Remember the Station is at Two Rock Coast Guard station - 765-7373.


