Well, folks, once again it's that time of the year to let your competitive juices start

flowing. Radiosport is alive and well, and is fully embodied in the ARRL's annual Field Day communications event. This year Field Day occurs on the weekend of June 28th and 29th. SCRA will be at a new and more accessible location this year, Youth Park at Fulton Road, across from Piner High School. We'll put up and operate three high frequency stations, one using single sideband, one using code, and one for newcomers, called the "get on the air" or GOTA station. We also hope to install and operate a station covering VHF-UHF. We'll have educational demonstrations and discussions, and our newer members and guests will have the chance to explore the mystery, wonder and frustration of high frequency radio communications.

I'm really excited about the efforts of this year's Field Day team, led by Brian N6IIY. Pat KG6JSL has agreed to provide the food, and he plans to bring the "toaster" vehicle to our operation. We need station operators and helpers with our ham radio promotional activities which are an integral part of the planned Field Day operation. In order to stay within our annual budget, we will be asking each participant to make a small contribution to offset the costs of renting the location, and providing the food and gasoline needed to run the generators. If you'd like to join our team, please let Brian know. We need your participation and support to make this event successful and memorable.

Field Day goes back a long way. My first Field Day occurred in the 1950s when my dad took me to the W6SF ham club's operation at Oak Park in Stockton, California. While never licensed, my dad had a keen interest in amateur radio and inspired and propelled my efforts to become a licensed radio amateur. At that particular Field Day, his job was to keep the generator operating. I remember the crackle of static and the stream of high speed Morse Code being sent by an operator using a Vibroplex mechanical keyer and a Johnson Viking Ranger transmitter. Today, we consider these items to be antiques (which clearly puts a date stamp on my forehead). But the impressions I retain from my first Field Day event so long ago were of sheer excitement.

Hopefully, you will come out to our Field Day operation this year and feel the same kind of excitement and gain the memories like those that have stimulated and maintained my interest in this wonderful hobby over many years.

I want to take this opportunity to acknowledge and thank the 2008 SCRA Board of Directors and our committee chairs for their effective service. Everyone on the Board and holding a committee chair has stepped up to the challenge and is providing wonderful service to this club for which we all thank you. If you would like to become a club leader, let us know. We have elections coming up in six months, and now is a good time to start thinking about the next team that will lead this club into the future.

I hope to see you at our meeting and at Field Day!

Field Day 2008: June 27, 28, 29

By the time you read this, Field Day will be just four weeks away!

We will be at the Youth Community Park, 1725 Fulton Rd, in Santa Rosa (across the street from Piner High School). This and the Wings Over Wine Country Air Show are the two best opportunities SCRA has to demonstrate amateur radio to the public, so we want to make a good showing.

Plans are shaping up, but we still need to tie up a few loose ends. We will be operating as a "2A" classification, meaning that we will have two HF transmitters. One of these will be on SSB and the other on CW. We need radios for these two stations, so if you can provide them, please let me know. One will be in the SCRA communication van (the "Toaster") and the other in John, KE5RI's motor home.

We will also have a Get-On-The-Air, or GOTA, station. I encourage all of our recently-licensed hams and even those old-timers that have not had an opportunity to get on the HF bands in the last year to give the GOTA station a try. It will be operating on SSB and possibly PSK-31. We will need control operators (General or higher) to allow the unlicensed and under-licensed hams the ability to work HF.

There is also room for a VHF/UHF station. If you have a VHF and/or UHF rig that can operate FM, CW, and SSB, please bring it along.

Pat Coyle, KG6JSL, will be coordinating the dinner Saturday night. There will be hamburgers, hot dogs, salad and beans. A donation of \$10 will be requested to offset the cost of the food and other Field Day expenses.

John Breckenridge, WB6FRZ, will be leading the Educational Activity. We have not yet determined the exact time of this activity, so watch for announcements on the SCRA website and your e-mail for further details.

First of all, I would like to hear from anyone who is hoping to participate in any way in Field Day this year. Even if you might only be there to observe for an hour or two to help logging, cooking, or whatever, please call me or send me an e-mail.

The event starts at 11:00am and runs until 11:00am Sunday morning, June 29. We will immediately start tearing down at 11:00am Sunday and should be leaving the park by 3:00pm.

ARES[®] and ICS-213

In the last ARES training session, I was asked how Radiogram (i.e. formal written traffic) messages

fit in with the use of form ICS-213. At that time I gave a fairly general answer to the question but, in light of the fact that nearly all of our emcomm work will be under the ICS scope of operations, I feel the subject needs additional discussion.

The ICS-213 office Speed Memo is not designed for (nor was it ever intended for) radio traffic. Comparing ICS-213 with the universal RADIOGRAM is like comparing a Phillips head screwdriver with a flat blade screwdriver. They each have their own distinct purpose and they are not interchangeable. ICS-213 "GENERAL MESSAGE" was designed for, and works well, for informal messages within an EOC or for delivery by a courier. It will not work effectively for radio *message traffic* that must be relayed through more than one station. There is no place for a complete address or a place to assign a *precedence* ... and there is no way to track a message. Where the ICS-213 form has been used (or tried to be used) to forward radio traffic through multiple stations, it has been found to be unwieldy and may take up to ten times longer to arrive (if ever). Unfortunately, most of the people making the decisions within emergency management are unfamiliar with radio communications and/or message traffic that must be delivered via a "multi-hop" mode.

People needing to send a message by radio, whether TACTICAL or FORMAL may bring to an emcomm station a message written on any form they want, or on plain paper, or in their head. The station supervisor or radio operator on duty will, if necessary, assist the person to format the message. However, once the message is worded, skilled radio operators should NEVER modify, change, or attempt to "improve" any message text, (or the preamble) any more than a postal clerk would open an envelope and change a message or change the "class" of a piece of mail! It is none of our business what the message says or if it makes sense to us. As emcomm traffic handlers, our job is to relay and/or deliver all messages <u>exactly</u> as they were originated. Essential information needed for radio transmission is: WHO – the message is going to.

WHERE – as complete address as possible ... plus telephone number(s) if possible.

WHAT – the person sending the message wants to say. FROM – the signature (and return address or method of contact if a reply is desired).

The station supervisor or duty operator will add the preamble:

NUMBER/PRECEDENCE/HANDLING INSTRUC-TIONS/STATION OF ORIGIN/CHECK/PLACE OF ORIGIN/TIME/DATE

It is important to always use the same format for all modes and never trust your memory for any message whether it is tactical or formal. Also, keep in mind that failure to write and log all radio traffic may cause serious headaches. It is possible (and probable), especially in a major disaster, that your station log will become a legal document in the debriefing of the event.

The comment is often made that, "The RADIOGRAM" format is too complicated to learn." What is so complicated about a one-line preamble with six or eight simple pieces of key information (to ensure that the message is delivered and recorded), an address and telephone number, a short message, and a signature? There is nothing more simple and "plain" than a well composed message TEXT transmitted using the universal RADIOGRAM format. The ability to communicate with the ICS is absolutely critical. An essential method for ensuring the ability to communicate is by using common terminology and clear text. A critical part of an effective multi-agency incident management system is for all communications to be in plain English. That is, use clear text. Do not use radio codes, agencyspecific codes, or jargon.

REMEMBER ... we do NOT send a "form"! Radio operators send <u>messages</u> using the <u>universal format</u>. The <u>universal format</u> works for all government agencies, NGO's (non-governmental organizations), and the general public ... <u>anyone!</u> Whether the message is handwritten or typed, plain paper is oftentimes the easiest and best. The only time we must use a "form" is for the final delivery of a message that is mailed or delivered by courier to the addressee.

Hams Heed the Call: Tornadoes Sweep Through Colorado

On Thursday, May 22 at approximately noon MDT, a large tornado touched down in northern Colorado near the town of Windsor. Windsor, with a population of nearly 19,000, is located approximately 10 miles southeast of Fort Collins, and 50 miles north of Denver. According to ARRL Colorado Section Manager Jeff Ryan, KORM, initial reports indicated that there was the possibility of extensive damage. Ryan said that Colorado ARES District 10 was activated and David Markham, W0CBI, the Colorado Section Emergency Coordinator, monitored the situation.

The funnel cloud, accompanied by golf-ball sized hail, blackened the skies over Windsor as it knocked down power lines, shredded crops in fields outside the city and blasted whole neighborhoods; the southeast side of town was hit the worst by the storm. "It will be a long time before the town recovers from this," Windsor Mayor John Vasquez said.

Ryan said reports indicated the Windsor tornado was just one of several that swept across northern Colorado and part of Wyoming: "The storm resulted in one fatality, and more than 100 people were treated on the scene for some type of injury with another 18 people treated at area hospitals. Damage is widespread and includes homes and business in Weld and Larimer Counties. We also received damage reports from the smaller towns of Gilcrest and Platteville."

The Weld County Sheriff's Office reported that the lone fatality, Oscar Manchester, 52, a US Marine and Vietnam veteran, was killed in a recreational vehicle that was destroyed in the storm at a campground west of Greeley, about 60 miles north of Denver.

Colorado ARES District 10 Emergency Coordinator Randy Long, W0AVV, reported that 31 operators provided communications service to the Emergency Operations Center and Fire Department in Windsor, the Weld County Emergency Operations Center, the Larimer County Emergency Operations Center, the City of Loveland Emergency Operations Center, the Loveland Mobile Command post and two Red Cross shelters.

"On Friday, the town was still without power and remained so until local utilities could complete a survey of electrical transmission lines in the affected area that is expected to take up to 48 hours," Ryan said. "A mandatory evacuation for sections of Windsor is in effect due to gas leaks and downed power lines. The National Guard is on duty and is responsible for escorting emergency responders in and out of the area."

Colorado Governor Bill Ritter ordered the National Guard to aid rescue and cleanup efforts. He visited the town Thursday evening, saying the number of homes damaged was "significant" and declared a state of emergency for Weld County. Representatives from FEMA are on the scene conducting damage assessments. On Monday, President Bush approved Colorado's request for federal disaster aid to help with the costs of the storms and tornadoes, and declared Weld and Larimer Counties federal disaster areas.

On Friday, Markham placed an additional 15 Amateur Radio operators in Larimer and Weld County on standby in anticipation of an overnight shift; he also requested adjacent districts to prepare in support of the ongoing operations if necessary.

Windsor, Fort Collins and Loveland lie in the shadow of the Rocky Mountains, where the Great Plains give way to steep hills. "It's very unusual to see [a tornado like] this by a mountain range. It's kind of a freak thing," said Captain Steve Fleming of the Poudre Fire Authority.

Ryan said that at the peak of the ARES operation, "Colorado ARES District 10 had 55 operators supporting emergency response and relief efforts in the aftermath of the tornado that touched down near Windsor."

(I couldn't tell which organization was sponsoring her for the walk.) What a great thing to be able to tell her son later in life that he had participated in the Human Race at only 13 days old. There were greyhounds and even people dressed as characters from The Wizard of Oz. The sea of people took me through Howarth Park where I've been many times during the 47 years I've lived here. We walked through neighborhoods and one home along the route had set out a plate of fresh cut fruit for people to help themselves. What a great experience it was walking for my club SCRA.

The board is also authorized to sell the club generator. John KE5RI volunteered to research a price for the generator.

8. Future Programs – Becky KE6PZV reported that all programs have been firmed up through September. The field trip to KPH will be delayed until October and may be com-

bined with the fall picnic.

9. Website Expense – Dave W6IBC reported that our web master Jeff KK6JAB has moved the SCRA website to a new server which is charging a monthly fee. Dave W6IBC will contact Jeff to find out whether we can stay on the old server which was free. Dave KF6CLG will also contact Steve Carneglia of CDS.

10 Toaster Fund – Dave W6IBC reported that a donation of \$305 was made to the Toaster fund. Since the routine expenses for the Toaster have been coming out of the general fund, it was decided to place this money in the general fund. **11 Digipeater** – Dave W6IBC reported that Pat KG6JSL has a radio and TNC which will be installed at Bob's KE6TGI house. The repeater will operate on 144.390 MHz and will be used for APRS.

12 AV Equipment – Dave W6IBC reported that he has been using his own digital projector at club meetings. Since his term as president will be ending soon, he asked the BOD to consider what will be used in the future. Should the club consider buy a projector or possibly have a member donate one to the club now that we are getting our 401C status.

13 Club Logo – Dave KF6CLG showed a polo shirt with the club logo embroidered on it. The standard size shirts are \$18.00 each in quantities of 6 or more. Dave Santori will circulate an order sheet at the next meeting. The BOD also authorized \$300 for KF6CLG to purchase 100 club patches for resale to members.

14 501C3 Status – Dave W6IBC reported that the SCRA application for non-profit status has been submitted to the IRS.

15 Technician Classes – John WB6FRZ reported that the next Technician class will be on May 31 – June 1 in Sebastopol. The board authorized \$200 up-front money to purchase the manuals for this class, costs to be recovered from fees charged to attendees.
