A regular member who has rendered outstanding service to SIRARC may, by vote of the membership, be awarded the title of HONDRARY KEY and be retained on the SIRARC Membership Roll, should he lose his qualifications for membership in SQNS IN RETIREMENT, INC.

Married August 1, 1925 to Margaret Jane Maloney. On August 1, 1982, we will celebrate 57 years of wonderful married life. We have one son, Donald, and two grandaughters.

EDUCATION:

8 years elementary education in a one-room country school - one teacher with an average of 30 students, covering all grades from primary to the eighth. Thanks to the old basic educational system of the three R's, plus grammar, history and geography, which fully prepared me for high school and college without any problems.

Graduated from Kinsley, Kansas, High School with Class of 1922. We had our 50th Class Reunion in 1972, with 22 of the living members present. Our ranks have now dwindled to 15 and the 60th Reunion is planned for 1982. The friend-ship of our Class was outstanding and through the years we have all remained in contact through a round-robin letter which circulates twice a year. Through the years, each member of the Class has established a record for him or herself of which we are all proud.

Paul was born in Santa Paula, California in 1905. He became a member of SIRARC through his membership in Redwood City El Camino Branch No. 16. He and his wife Carol moved to their new home in Ventura shortly after his term as President of SIRARC and, in recognition of his dedicated contribution to the Club, was awarded an Honorary Membership on February 25, 1977. Due to certain possible conflict with the Rules and Procedures of our parent organization, Sons In Retirement, Incorporated, and objections on the part of the State Board, it was mutually agreed to change this Title to HONORARY KEY in lieu of Honorary Member. EDUCATION:

Paul attended both the Santa Paula and Oxnard High Schools in Ventura County. He graduated from the University of Southern California in 1926 with a Degree of Bachelor of Science in Electrical Engineering.

PROFESSIONAL CAREER:

Paul worked for the General Electrical Company in Schenectady, New York, from 1926 to 1929, in industrial control design engineering and industrial motor sales.

He was transferred to the Los Angeles District Office in 1929, where he remained until 1933 when he accepted a position with the Southern California Edison Company as Industrial Heating Specialist and Rate Analyst.

In 1939 Paul accepted a position as District Manager for Line Material Company; his territory covered California, Arizona and Nevada. Line Material Company subsequently became a Division of McGraw Edison Company and his territory was expanded to include all of the Western States, Hawaii and Alaska. He retired from McGraw Edison Company in 1970.

It is interesting to note that Paul received his first license in 1922, with the call letters of 6BF. He used Ford Spark Coils with the Spark Cap connected directly to the Antenna and ground with a loose coupler and galena detector as a receiver. He later moved up to a rotary gap and a one quarter KW transformer and then on to a vacuum tube regenerative receiver and a five-watt transmitter with A.C. on the plate.

College, the job, getting married, etc., required so much attention that Paul was unable to continue with Ham Radio and lost his two-letter Call. However, in 1936 he found the time to return to Ham Radio and received the Call of W608Y.

Inasmuch as the Club was young; its membership small, there was reluctance on the part of the membership to step forward and offer their services as President. Our Vice President, W6HCE Al Bernes was too deeply involved in other organizations to accept the responsibilty. Paul came forward and offered his services — SIRARC was very fortunate and will be forever grateful. His talent and dedication was a great factor in continuing to establish a solid base for our organization.

Thanks very much for "meeting and conferring" with me and Sir Millard George on the matter of SIRARCS honorary and associate memberships, March 3rd at the Blue Dolphin in San Leandro.

Attached is copy of Sirarcs' letter of March 8th, over the signatures of Charles Buckter, President and Valter Jones, Sec. covering the subject of our discussion, and also a copy of my reply thereto.

As suggested, I include the definitions of the following references used in our discussion:

SIRARC- a statewide activity of Sons In Retirement, Inc., a non-profit mutual-benefit corporation of California;

ACTIVITY- an organizational Unit for performing a specific function;
